TERMS AND CONDITIONS

- The invoice for this purchase order will be paid based on the quantities and unit prices specified above, unless a maximum allowable quantity overage is stated below.

 2) Freight, unless indicated above, will not be paid. If delivery instructions include an account number to bill, delivery by other means will not be paid.

 3) The delivery due date is the date by which the product must be received at the ship to address for this PO to be valid. Late delivery must be approved by requestor prior to shipment.

 4) Partial shipments, unless requested are discouraged.
- 5) Any changes to products or material described in this purchase order or any accompanying specifications must be communicated to OneTouchPoint for review prior to delivery.

GENERAL REQUIREMENTS

The following requirements apply to all materials being received by OneTouchPoint unless otherwise specifically indicated.

A completed manifest or packing list must be included with each shipment. The packing list must contain the total number of cartons, quantity per carton, inner packaging, and total number of forms or units shipped. For numeric forms, a list containing number sequences and missing numbers, if applicable. Orders shipping in numerical sequence must be palletized with low numbers on top. Pallets not to exceed 54" total height (including pallet).

PACKAGING

All carton quantities must be the same throughout.

Partial/funt cartons are permitted only for pick and pack and critically numbered forms.

Partial cartons should be distinguished from full cartons and be located on top of the shipment and marked as a "partial" carton.

Only one (1) product per carton. Cartons with more than one product must be labeled as "mixed product".

Only one (1) product per carron. Carrons with more than one product must be labeled as "mixed product".

Gaylord or bulk packaging is not acceptable.

All inner carron packaging units/SKU's (stock keeping units) must be the same throughout. Runt SKU's are not acceptable.

Forms must be packed in 200# test carron with filler in empty spaces.

Individual carrons are not to exceed 50 pounds.

Inner carron packaging units/SKU's must be identified with the customer form number or OneTouchPoint purchase order number.

LABELING

Package/Carton labeling must be printed electronically (hand written labels not acceptable)
All human readable information must be a minimum of 10pt font.

- Labeling information must include the following information (where available): Product/Part/Form Number
 - Revision

 - Product Description
 - Unit of Measure (Each, Pkg, Carton, Roll, etc)
 Quantity per UOM (i.e. 200/Pkg)

 - Quantity per carton Carton x/y (i.e. 1/10, 2/10...10/10)
 - Purchase Order Number

For sequentially numbered products/parts/forms, must include numerical sequence each carton contains

ADVANCE SHIPPING NOTIFICATION (ASN) & DELIVERY APPOINTMENTS

Advance shirpfing not included (ask) a Debivert Aprovintment's Shipments exceeding 10 or more pallets require a scheduled delivery appointment. Suppliers shipping product not directly requested by OneTouchPoint must provide Advance Shipping Notice (ASN) at least 24 hours prior to delivery. Note: when scheduling a delivery appointment please include supplier name or shipping location, number of pallets and carrier.
